ACEHR Update



ACEHR last met face-to-face on 19-20 November 2012, followed by conference calls on 10 January and 28 February 2013, which were focused on 2013 ACEHR report to NIST Director (as chair of NEHRP Interagency Coordinating Committee - ICC)

Legislation Status


- PL 108-360, National Earthquake Hazards Reduction Program Reauthorization Act of 2004, remains in effect (though budget authorizations expired 30 September 2009)
- Agencies continuing their ongoing activities since authorized funds expired
- Reauthorization hearing conducted by Technology & Innovation
 Subcommittee of House Science, Space, & Technology Committee on 7
 April 2011
- Review hearing conducted by Research & Technology Subcommittee of House Science, Space, & Technology Committee on 29 July 2014
- July hearing indicated potential bipartisan interest in new NEHRP reauthorization








- Annual report on FY 2012 activities released in February 2014

 activities is being prepared and will then undergo interagency review


